Senden Sie den kompletten Antrag mit einer Bearbeitungsgebühr von € 30,00 (bar, per Euro-Scheck) an unsere Botschaft zurück. Nach Überprüfung des Antrages leiten wir diesen dann an das Innenministerium in Windhoek weiter. Nach dortiger Genehmigung des Antrages werden weitere €75,00 fällig.

Besuchen Sie bitte, dass die Aufnahme einer Beschäftigung in Namibia für Ausländer weitgehend eingeschränkt wurden, da freie Arbeitsplätze in erster Linie mit Namibiern besetzt werden müssen. Nur wenn dies nicht möglich ist, gibt es Ausnahmegenehmigungen. Die staatliche Kontrolle ist jedoch sehr genau.
